#### **ICT POLICY**

#### **Preamble**

Information and Communication Technology (ICT) broadly refers to technological tools and services that handle and communicate information. ICT is widely used in our everyday life and its need is ever-growing in the education, particularly in teaching and learning due to its ability to enhance the quality of education, increase in the access to educational resources, and improve communication between educators and learners in an educational institution.

C. M. P. Degree College (refer as the "College" in the policy document) provides ICT resources and services to support the educational, research and administrative activities of the institution in order to enhance the access, efficiency, equity, quality, productivity, and inclusion. Therefore, the college has articulated a well-defined policy for the use of all ICT resources, tools and services at the institution.

#### <u>Scope</u>

The ICT Policy of the C. M. P. Degree College adheres to the United Nations Sustainable Development Goal-4 (SDG-4) with the vision to "Ensure inclusive and equitable quality education and promote lifelong learning opportunities for all".

The policy governs the usage of ICT resources and services from an end user's perspective. The policy is applicable to all individuals/ users/ students /teaching/Non-teaching staffs who use the ICT resources and services of the College.

#### **Objectives**

The objective of this policy is to ensure proper access to and usage of C. M. P. Degree College's ICT resources and prevent their misuse by the users. The use of the resources and services provided by the College implies the user's agreement to be governed by this policy.

The key objectives of the policy are;

- ➢ To maintain, secure and ensure legal and appropriate use of ICT infrastructure established by the College on the campus.
- To establish college-wide strategies and responsibilities for protecting the confidentiality, integrity, and availability of the information assets (i.e., data, information system, network devices, intellectual property rights (IPR), etc.) that are accessed, created, managed and/or controlled by the College.
- > To build ICT enabled lifelong learning process/pathways.

- To expand access to educational opportunities as well as to advance inclusion and promote equity.
- > To enhance the relevance of quality education.

- ICT Cell shall ensure resolution of all incidents related to the security aspects of this policy by their users. Implementing agency itself or through the outsourced agency or service provider shall provide the requisite support in this regard.
- ICT Cell shall ensure the use of ICT resources for those activities that are consistent with the academic, research and public service mission of the University and are not "Prohibited Activities".
- ICT Cell shall ensure that all users shall comply to and abide by existing national, state and other applicable laws such as IT Act 2000, copyright laws IPR and any amendments/revisions in it.
- ICT Cell shall provide access to college website, Library website, Journal website, CMP Live (online Class portal), Online Admission Portal, Learning Management System (LMS), Webmail as well as use of scholarly and/or work-related tools, including access to the certain computer systems, servers, software and databases and the internet. ICT Cell may also restrict any access to any user to such services with the permission of the Competent Authority of the C.M.P. Degree College (Principal of the College).
- ICT Cell shall strive to ensure that the users of the C.M.P. Degree College shall not install any network/security device on the network without consultation with the ICT Cell.
- The competent authority of C.M.P. Degree College shall ensure proper dissemination of this policy.

When an individual uses College's ICT resources and services, and accepts any computing accounts issued by college, it means that the individual agrees to comply with this and all other computing related policies. It is the responsibility of the individual to keep oneself up-to-date on changes in the ICT policy of the College and adapt to those changes as necessary from time to time.
