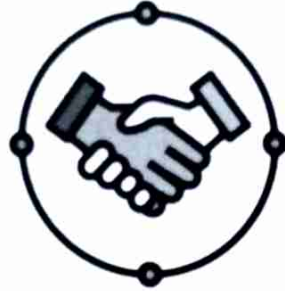

## Memorandum of Understanding

### Between CMP Degree College, Prayagraj & ICFRE-ERC Prayagraj

This MoU made and entered into on this 2<sup>nd</sup> day of August Two Thousand twenty four between C.M.P. Degree College, Prayagraj (hereinafter called CMPDC) represented herein by its Prof. Ajay Prakash Khare (Principal, C.M.P. Degree College, Prayagraj) (hereinafter referred as 'First Party' and CMPDC, the academic institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns). At Mahatma Gandhi Marg, George Town, Prayagraj, Uttar Pradesh 211002.

And

ICFRE-Ecorehabilitation Centre, Prayagraj (hereinafter referred as 'Second Party) having its Head office at 3/1, Lajpat Rai Road, New Katra, Prayagraj-211002 (hereinafter called "ICFRE-ERC) a constituent Research Institution of the Indian Council of Forestry Research and Education (ICFRE), Dehradun. was established in October 1992 as an advanced Centre under the umbrella of ICFRE, Dehradun. Presently, it is a centre of ICFRE-Forest Research Institute (FRI), Dehradun. The Centre aims to nurture and cultivate professional excellence in the field of social forestry and Eco-rehabilitation in the state of Uttar Pradesh.

ICFRE-ERC, which expression shall where the context so admits, include its successors and (permitted assigns) of the other part.

Each CMPDC and ICFRE-ERC here under are also referred to separately as the ("Party I and Party II) or together as the ("Parties").

#### 2 Preamble

- 2.1 WHEREAS CMP Degree College, Prayagraj desires to collaborate with, PARTY II, PARTY II to work on." (hereinafter called as MOU) .
- 2.2 WHEREAS PARTY-II has all necessary facilities and expertise for undertaking the Projects and agreed to collaborate with CMPDC, Prayagraj
- 2.3 WHEREAS based on the results of the PROJECT, CMP Degree College and PARTY II, may jointly submit a separate project to any funding agency.

Now, therefore, the parties have following understandings:

#### 3. Responsibilities under the approved MOU

##### (I) PARTY II: ICFRE-ERC, Prayagraj

- a) To provide the available Plant saplings for plantation drives in different location.
- b) To exchange the student for research collaboration.
- c) To organize training program and workshops jointly.
- d) To help in biodiversity conservation studies of Prayagraj and to prepare Prayagraj Biodiversity register.
- e) Joint R & D projects for research enrichment and collaborative work.

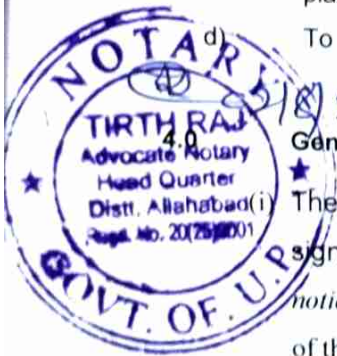
##### (II) Party I: CMPDC, Prayagraj

- a) To provide plant identification services.
- b) An Authorship/contribution in scientific publications communicated from CMP College, Allahabad.
- c) Collaboration for joint R&D projects to develop digital library of Indian medicinal plants and their metabolites.
- d) To prepare Prayagraj Biodiversity register.

#### General Provisions

The MoU shall remain valid for a period of five (...5...) years from the last date of signing of the MoU. Either party is free to terminate the agreement by giving *one-month notice* in advance. In the event of termination of the agreement, the rights and obligations of the parties shall be settled by mutual discussion.

- (III) The progress of implementation of the any project shall be reviewed by CMP DC and **ICFRE-ERC, Prayagraj**, as mutually decided and the benefits of the collaboration shall be shared mutually.

### Between CMP Degree College, Prayagraj & ICFRE-ERC Prayagraj

- (ii) Both parties can visit the collaborating institutes as per requirements of the PROJECT and shall have adequate insurance coverage without any financial liability on each other.
- (iii) The parties shall consult each other for any publication in respect of research work. These publications (papers, reports etc.) shall be in the names of actual research workers, wherein it will be duly acknowledged that the work has been carried out under the collaborative research program of Party I and PARTY II. As a part of collaboration, the outcomes of the research under this Agreement shall develop joint publication.
- (iv) Any publication, document and/or paper arising out of joint work conducted by the participants pursuant to this MoU, shall be jointly owned as per the guidelines issued by the funding agency. The use of the name, logo and/or official emblem of the participants on any publication, document and/or paper will require prior permission of both the participants. It may however be ensured that the official emblem and logo shall not be misused.  
During the tenure of the MoU and thereafter parties undertake on its behalf and on behalf of its affiliates, employees, associates, consultants, professional advisors (collectively referred to as "Permitted Users") to whom information of the MoU is disclosed and shall maintain its confidentiality and shall also prevent any disclosure of the information to any third party. Both parties shall allow access to the information to only Permitted Users who are evaluating the data and information and they shall maintain the confidentiality of the same as their own data.
- (vi) The annual maintenance of the facility including all the instruments shall be the responsibility of each party without any financial liability on each other.
- (vii) Nothing contained herein shall constitute this a partnership or joint venture agreement or constitute either party as the partner, principal or agent of the other, this being a MoU between independent contracting entities.

- (viii) No amendment or modification of this MoU shall be valid unless the same is made in writing by all the parties or their authorized representatives and specifically stating the same to be an amendment of this MoU. The modifications shall be effective from the date on which they are made, unless otherwise agreed to.
- (ix) The parties will use their best efforts to settle all matters in dispute amicably. All disputes and differences of any kind related to this MoU shall be jointly settled between Principal, CMPDC, PARTY-I and Director ICFRE-ERC Party-II.
- (x) The Memorandum may be amended or revised if both the parties agree. Such amendments or revision shall be effective from the date of signature. Amendments may be decided at any time and shall be made in writing upon mutual consent of the parties.

This Mou has been executed in two originals , one of which has been retained by the first party and the other by the second party.
