On November 9th 2022, a “National Workshop and Awareness Programme on Legal Aid and Access to Justice for All” was organized by the Legal Aid & Services Clinic, C.M.P Degree College at the Main Campus, C.M.P. The event was organized to mark the celebration of National Legal Services Day on 9th November to commemorate the commencement of Legal Service Authorities Act, 1987 which came into force on November 9th, 1995. The Chief Guest of the event was Dr. Lucky, Civil Judge (Senior Division)/ACJM & Secretary, District Legal Services Authority, Prayagraj. 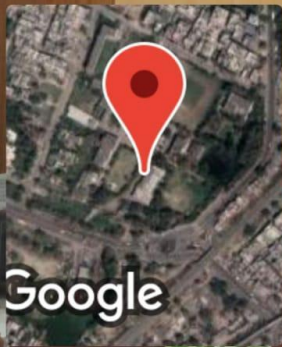
