The seminar was distributed in three sessions. First technical session was titled "human rights of social groups." Kumar, Assistant Professor, University of Allahabad, Prayagraj. Second technical session was titled "human rights and persons with disabilities." Chairpersons of the session were Dr Hanuman Prasad, Retired Associate Professor of CMP Degree College, Prayagraj and Dr Ajay Kumar Singh, Assistant Professor, University of Allahabad, Prayagraj. Third technical session was titled "redressal of human rights violation" Chairpersons of the session were Dr. Murari Verma, Associate Professor, Meerut College, Meerut. And Mr. Haribansh Singh, Assistant Professor, University of Allahabad.

It is rightly said that no one can change the world in one day but everyone can do their part. This is a small initiative from our side to make world a better place to live in. The laws and policies of a country can appear to protect human rights but be used in a way that create inequality and actually violate the human rights. This means that the laws of a country must be reviewed and compared to international standards to make clear what impact the laws are having on the rights of their citizens. Legal cases and decisions are just as important as the written laws of a country regardless of what a law says, what matters is how it is interpreted. The Seminar proposed that an international web site be created that would contain important legal cases from international courts and the courts of individual countries. All cases would be compared to international human rights standards and norms. The web site would also have a user friendly guide to international human rights laws and standards. Individual countries would be responsible for their own web sites which would report cases from their country. This would likely be done by each country's ministry of justice or by other organizations like law schools or human rights bodies. The international web site, which would be a collection of all national sites, would be run by the UN's Office of the High Commissioner for Human Rights.

Seminar participants recognized that there are already many groups that are involved in this sort of review (for example, university departments, social policy agencies and human rights organizations). It was suggested that the expertise and resources of these groups be more focused on human rights issues. Information collected relating to human rights issues could be separately documented and made available in a form that others can understand and share.
