On the occasion of International Human Rights Day, an online seminar was organized under the joint aegis of District Legal Services Authority and Legal Aid and Service Clinic at CMP Degree College on 10 December 2020. On this occasion, District Legal Services Authority (DLSA) Prayagraj Nodal Officer and ADJ Madam Nisha Jha and Secretary, Chandramani ji along with Shri Utsav Gaurav Raj, Railway Magistrate, Prayagraj and Madam Nazia Nafees, founder and social worker of Al-Kausar Society, were the chief guests. On this occasion, District Legal Services Authority (DLSA) Prayagraj Nodal Officer and ADJ Madam Nisha Jha and Secretary, Chandramani ji along with Shri Utsav Gaurav Raj, Railway Magistrate, Prayagraj and Madam Nazia Nafees, founder and social worker of Al-Kausar Society, were the chief guests. College Principal Dr. Brijesh Kumar welcomed the guests and the program was presided over by Senior Vice President of Kayastha Pathshala, Ch. Raghavendra Nath Singh. On this occasion, ADJ Madam Nisha Jha highlighted the role of judiciary in the context of implementation of human rights laws. Railway Magistrate Shri Utsav Gaurav Raj took the discussion forward in the context of human rights development and Indian culture. Shri Chandramani ji discussed the issues of human rights violations. Madam Nazia Nafees mentioned the role of duties in the context of the implementation of human rights.

Dr. A.P. Singh, Convenor of the Law Department of the college, explained the role of the state in the implementation of human rights. While Dr. Ritu Raghuvanshi discussed the accountability of the judiciary as a protector of human rights, Dr. R.D. Kishore presented a discussion on human rights laws. Dr. Govind Gaurav of the Department of Political Science gave a detailed discussion on the major issues going on in the context of universality, implementation, and inclusion of human rights at the global level.
