- 1. Unsealed & conditional tenders shall not be accepted.
- 2. Bidders should have at least six months of experience working in an educational institute.
- 3. Bidders have to submit Proof of PAN, Experience Certificate, and Aadhar number.
- 4. Bidders are required to deposit either a cash receipt from the Account Section or a Demand Draft of Rs. 1000 (Rupees one thousand only) as the cost of the tender form in favour of Principal, C.M.P. Degree College, Prayagraj.
- Bidders are required to deposit Rs. 5000 (Rupees Five thousand only) as Earnest Money in the form of a Demand draft in favour of the Principal, C.M.P. Degree College, Prayagraj.
- The successful Bidder will have to deposit 100% of the biddingamount at the time of taking charge in the form of a Demand draft/cash in favour of the Principal, C.M.P.
